VOLUME TICKET PROGRAM GUIDELINES AND AGREEMENT

2009/2010 Season

I. Introduction

The Volume Ticket program allows **Ski Clubs, Ski Councils, Corporate Groups and Associations** to purchase Stowe Mountain Resort Lift Ticket vouchers at a discounted rate for **Adults** (13-64 years of age) rate of **\$50.00** and/or a **Child/Senior** (6-12 & 65+ years of age) rate of **\$45.00**. These vouchers are sold in volume packs. The first order or original order of 100 is non-refundable. All re-orders must be in blocks of 50 (refundable) and can be combined Adult and Child/Senior voucher orders. Full day adult, child or senior lift ticket vouchers are redeemable any day of the week, **no black-outs**. The vouchers are valid for the **09/10 season only and expire on 4/18/10 (dates subject to change with out notice)**. These vouchers have no cash value.

The intent of this program is to offer ski clubs, councils, Groups and/or Associations a reduced rate lift voucher with a **1st order non-refundable minimum of 100 vouchers and a minimum re-order of 50 vouchers** (re-fundable when returned by no later than May 1, 2010).

These vouchers may not be resold. Violations of this policy may lead to suspension of your participation in the program. If a suspension is warranted, all remaining vouchers become invalid and no refunds will be issued.

II. Voucher Order Procedure

A. The minimum number of vouchers that may be ordered in the first **non-refundable** purchase of **100** at an **Adult** (13-64 years of age) rate of **\$50.00** and/or a **Child/Senior** (6-12 & 65+ years of age) rate of **\$45.00**. Re-Orders must be made in blocks of **50** and **are refundable** at the rate purchased when returned by no later than May 1, 2010.

B. All unused vouchers must be returned by May 1, 2010 to receive a refund at the **Adult** rate of **\$50.00** and a **Child/Senior** rate of **\$45.00** (**Please note:** The initial first order of 100 tickets is non-refundable. The return policy is only for the re-ordered blocks of 50.)
